



GENERAL VOLUNTEER WAIVER

I agree to assume such risk and to waive any claim for any physical injury, or any kind whatsoever arising out of, or in connection to my participation with Lakeside's River Park Conservancy. I further agree to release, indemnify and hold harmless Lakeside's River Park Conservancy and its directors, officers, employees, contractors, agents, affiliates and representatives against any and all claims, demands, losses, liabilities, judgments and costs (including reasonable attorney's fees) which may occur out of or in connection to my participation with Lakeside's River Park Conservancy.

I will be personally responsible for any financial cost incurred as a result of my participation with Lakeside's River Park Conservancy, including and without limitation: transportation or medical expenses incurred as a result of any injury or illness.

I understand that Lakeside's River Park Conservancy will assume no liability for lost, misplaced, stolen and/or damaged personal property and I hereby release them from any such liability.

I also hereby authorize and consent that Lakeside's River Park Conservancy has the right to copyright, publish, use, sell or assign any and all photographic pictures, videotapes and/or sound recordings taken or made of me or in which I may be included in whole or part. I grant permission to allow these images and/or recordings to be put to legitimate use at the discretion of Lakeside's River Park Conservancy.
